Approval of the Minutes

Motion was made by Scott, seconded by Curtis to approve the minutes for the February 4, 2013 meeting as presented. Motion carried. Vote: 6 to 0.

Motion was made by Pattillo, seconded by Handley to add the following item to the agenda: update of possible lease to Angel Medical Center. Motion carried. Vote: 6 to 0.

Public Session

Dan Williams – You need to clean up Dogwood Drive.

Bob Simpson – I need to obtain a permit for an inside firing range. It will be located at the Burcliff building. It will be used by the local police departments, Southwestern Community College and for education of school children. There is a great need. It will be a NRA Range with insurance in place. I may need a variance for this use.

Mayor Collins said we cannot answer you tonight. Derek Roland, Land Use Administrator, said this property is zoned Secondary Commercial. He said this zone allows inside recreation. He said I am not sure that inside firing range is allowed. John Henning, Jr. said I will look at the ordinance.
