Alderman Pattillo said we need to do PR with our citizens. Sam Greenwood said we can post the newsletter on the web site. Mayor Collins said we could put an insert in the newspaper. Alderman Scott said the media does a good job on reporting the news. Alderman Pattillo said we need to do a monthly newsletter. Mike Decker said the cost is around \$3000.00. Alderman Scott said we could produce it in house and put it in the newspaper. The Board did not reach a decision on this issue.

The regular July 6, 2010 meeting of the Town of Franklin Board of Aldermen was continued at 5:30 P.M., Monday, July 19, 2010 in the Town Hall Board Room. Mayor Joe Collins presided. Aldermen Jerry Evans, Joyce Handley, Billy Mashburn, Carolyn Pattillo and Bob Scott were present. Alderman Verlin Curtis was absent.

#### **Board member absence**

Motion was made by Pattillo, seconded by Evans to excuse Alderman Verlin Curtis from the meeting because of a planned vacation. Motion carried. Vote: 5 to 0.

## <u>Presentation by Edwin (Terry) Terrel Meek, AIA, regarding design services for a development proposal for town property</u>

Edwin (Terry) Terrel Meek said my plan has three sections. He said they are as follows: (1) retrieval of information, (2) actual plan and (3) the completion of the drawings and a physical model. He said I have over thirty-five years of experience. He said I have completed projects in Andrews and Mars Hill. Mayor Collins asked what excites you about this project? Mr. Meek said it is close to downtown and we will be setting the bar for future growth. Alderman Pattillo said what are you doing in Andrews? Mr. Meek said it is an initiative to cause growth in the downtown area. Mayor Collins said what input will we have? Mr. Meek said it will be up to you how involved you want to be. #### Consideration of request for non-profit funding from REACH of Macon County

Ann Van Harlingen said it is critical for non-profit organizations to get support from local sources. She said the cost of providing shelter for one night is \$50.00. She said we have been full every night at the house. She said we need an in kind match from the community. A copy of the request is attached.

Motion was made by Handley, seconded by Pattillo to give \$4,000.00 out of the non-profit funds to REACH of Macon County to be used for shelter costs with John Henning, Jr. drawing up the necessary contract. Motion carried. Vote: 5 to 0.

#### Consideration of Resolution Opposing Federally Mandated Collective Bargaining

Sam Greenwood said the United States House of Representatives passed the Public Safety Employer-Employee Cooperation Act on July 1, 2010. He said this would require state and local governments to allow collective bargaining with public safety employees. He said North Carolina is a right to work state. Alderman Scott said the vote on this legislation was along party lines.

Motion was made by Handley, seconded by Evans to approve the resolution opposing federally mandated collective bargaining and to forward the resolution to the state's United States Senators. Motion carried. Vote: 4 to 1. Voting yes: Evans, Handley, Mashburn and Pattillo. Voting no: Scott. A copy of the resolution is attached.

John Henning, Jr. said Duke Energy is not generating electricity at Lake Emory. He said I will be emailing you more information on this situation.

John Henning, Jr. said there are some outstanding easements on the Crawford Branch Sewer project. He said we may need to do some inverse condemnation of these easements so that the project will not be delayed. He said we will pay the value of the property later.

Motion was made by Mashburn, seconded by Evans to instruct Town Manager Sam Greenwood and Town Attorney John Henning, Jr. to do inverse condemnation if necessary on the easements for the Crawford Branch Sewer project. Motion carried. Vote: 5 to 0.

John Henning, Jr. said we will be having a public hearing at the August 2, 2010 meeting on the Wal-Mart request for a special use permit. He said this is a quasi-judicial hearing. He said the Board will need to base their decision on the evidence given at the hearing. Mr. Henning said the Board cannot discuss this request before hand with citizens.
