January 4, 2021 meeting,

The Franklin Town Council held its monthly meeting on January 4, 2021 at 6:00 p.m. in the Town Hall Board Room. Mayor Robert S. Scott presided. Vice-Mayor Barbara McRae, Council Members Joe Collins, David Culpepper, Mike Lewis, and Dinah Mashburn were present.

Vice Mayor Barbara McRae and Council Member Jack Horton used Zoom to attend the meeting virtually.

In consideration of members attending virtually, Town Clerk Travis Tallent conducted roll call for each action that was taken.

The Pledge of Allegiance was led by Mayor Scott.

Adoption of the January 4, 2021 Town Council Agenda

Town Manager Summer Woodard asked to add some budget amendments to the consent agenda as item 4(E), discussion of a police cruiser purchase as item 7(B), and a closed session for attorney-client privilege as 7(C).

Motion was made by Horton, seconded by McRae to approve the agenda as amended. Motion carried. Vote: 6 to 0.

Town Attorney John Henning Jr. presented an updated Parades and Demonstrations Ordinance

New Business: Discussion on Strategic Planning Meeting

The Town Council directed the Town Manager to begin looking at options for a strategic planning meeting.

New Business: Discussion on Purchase of a Patrol Car

Police Chief Bill Harrell said that a police car had been damaged during Christmas and had been totaled. He said that the parked vehicle was struck by another vehicle and the driver had Geico insurance. A claim was made and it was looking as though the reimbursement for the damaged vehicle would be around \$15,000. He asked the board to use \$45,000 from fund balance in order to replace the vehicle since he could get a replacement fully outfitted for that cost. He said that the insurance payment would be going back into the fund balance.

Motion was made by Mashburn, seconded by Lewis to allow \$45,000 from fund balance to be used towards the purchase of a new patrol vehicle with the understanding that the Town Attorney would help to obtain an insurance reimbursement from Geico that would then go back into the fund balance. Motion carried. Vote: 6 to 0.

Motion was made by Culpepper, seconded by Mashburn to move into closed session pursuant to G.S. 143-318.11(a)(3) at 6:40 p.m. Motion carried. Vote: 6 to 0.

Motion was made by Mashburn, seconded by Lewis to allow the Town Manager and the Mayor to execute certain real estate documents on behalf of the Town of Franklin. Motion carried. Vote: 6 to 0.
