The regular meeting of the Franklin Town Council was held on Monday July 2, 2018 at 6 p.m. in the Town Hall Board Room. Mayor Robert S. Scott presided. Vice Mayor Barbara McRae, Council Members Joe Collins, David Culpepper, Adam Kimsey, Dinah Mashburn and Brandon McMahan were present.

Approval of the June 4, 2018 Town Council minutes

Motion was made by McRae, seconded by Collins to approve the June 4, 2018 meeting minutes. Motion carried. Vote: 6 to 0.

Adoption of the July 2, 2018 Town Council Agenda

Motion made by Culpepper to paint one side of Main Street parallel and tape the other side for a trial period. Motion died due to lack of a second.

Motion by Collins, seconded by McMahan to permanently change parking to parallel on the right side of Main Street to Commerce Street. Motion carried. Vote: 6 to 0.
